In lessons 2, 4, 6, 8, 10 and 12 you will find Assessment Exercises which require you to post a response of not more than 200 words on the Online Discussion Forum to a question about some aspect of that lesson. In addition to your initial posting, you will be required to make at least one further posting of at least 50 words which interacts with what your online tutor and other students have said. The second posting for each assessment exercise must be within 7 calendar days of the due date for the initial posting.

b. Greek Exegesis Option

Learning Outcomes: 1, 2, 5, 6

Due Dates: Midnight Sunday end of Semester Weeks 2 and 4 (Part a).

Parts b and c to be set by tutor

Percentage Weighting: 20%

This assessment consists of three parts:

Two postings on the online forums.

You will need to post a response to the discussion forum Assessment Exercises in lesson 2 & 4 along with the students doing the English Exegesis option. See above for details about what is required. This will make up 5% of your grade.

ii. Four live Greek tutorials.

You will participate in 4 online audio tutorials with a Greek tutor where you will read and translate from the Greek text and discuss textual and grammatical insights. These sessions will be based around set passages from John's Gospel and will operate live using Laidlaw's *Adobe Connect Pro* online conferencing tool. Your tutor will advise you of the details for these tutorials.

iii. Two translations from the Greek text.

For two of the four tutorials you will submit a written translation. The first will be a more critical translation and will include notes. The second will be a more dynamic equivalent translation. These translations and your participation in the four tutorials will make up 15% of your grade.

2. An Exegetical Essay

You are required to write an exegetical essay on ONE of the passages listed below. Further details of what is expected in your exegetical essay are included with the course materials. In addition, the processes and structure outlined in the Biblical Interpretation (111) course will be helpful. You should include in your essay some reflection upon the significance of the chosen passage for Christian life and ministry today.

i. John 4:19-26ii. John 11:17-28iii. John 15:1-12

Participation in Online Discussion Forum: Greek Exegesis Option

The first two forums will be graded as for the English Exegesis option above (5% of grade). The other two parts will be assessed against the following:

- Participation: Quality of participation in the tutorials, including timely presentation of translation samples and insightfulness in discussion.
- Accurate Translation: That the translation is true to the Hebrew text.
- Critical Notes: That the translation is well supported with notes.
- *Textual Analysis:* Key textual issues, such as syntactical constructions and manuscript variants, are identified and incorporated into the translation.
- Contemporary Appropriateness: That the translation reads well for English speakers in NZ today.

Exegetical Essay

- Utilisation of appropriate tools and resources (commentaries and other academic studies of John's Gospel)
- · Clarity and depth of analysis
- Demonstration of exegetical competence in handling the text
- Thoughtful application.
- Communication and Presentation: Clarity, format, spelling, grammar; annotation and bibliography.
