A. CONTENT OVERVIEW:

- 1. Paul and Corinthian Christianity, including the planting of the church in Corinth, the composition of the Corinthian correspondence, the theological mood of the Corinthian church, the problem of food offered to idols, the Lord's Supper, competing conceptions of apostleship, etc.
- 2. An exegesis of selected texts from chapters 1-7 and 11-15 of 1 Corinthians, and an examination of the issues covered in those passages.
- 3. An examination of several key issues within 1 Corinthians, including Paul's apostleship and authority, wisdom and knowledge, Christian freedom.
- 4. Selected elements of Pauline theology, including eschatology, Christ's death and resurrection, Spirituality and the Spirit, the church.

B. ASSESSMENT TASKS AND DUE DATES: ENGLISH OPTION

The student will be provided with an English translation (NRSV or NIV2000) without subheadings and minimal chapter and verse markers. This assignment requires the reading of 1 Corinthians from beginning to end, and making an initial analysis of the text of 1 Corinthians as a whole document, discerning each major section and points of conclusion. This analysis will involve observation of connecting words, a brief summary of each section, and a mapping of the letter as a whole. (one or at most two A4 pages in flow chart format)

Write an essay on **ONE** of the following themes:

- Christian Leadership
- Unity
- Love
- Sexuality
- Gathered worship
- Lessons for mission
- The resurrection
- The place of women

The essay is to be based on 1 Corinthians and one aspect of Paul's thought within the letter. You can also draw comparison and links to other Pauline passages, and if appropriate, other biblical texts. However, this is an essay on 1 Corinthians. The essay cannot be based on one short passage but must be broad enough to demonstrate engagement across more than one small part of the letter. It should tell how Paul develops the theme within the letter and then consider the implications of his thought for life today. The implications for life today should take up no more than about 10% of the total word count.

A. CRITERIA FOR ASSESSMENT: ENGLISH OPTION

A. ASSESSMENT TASKS AND DUE DATES: GREEK OPTION

Critical Translation

Students are required to write a *critical translation* of THREE selected passages of 1 Corinthians. This translation should include footnotes, explaining the choices *where it is needed* and where there are textual variants and *issues*. The translation should be prepared for a general English speaking competent reader in today's NZ context. This can be done in conjunction with tutorials reading through the text of these chapters through the semester. The student will also be required to prepare a *structural analysis and translation* of ONE of these passages, and a *'dynamic equivalent'* translation of ONE OTHER of the passages. The passages to be worked with will be notified to the students prior to the start of the semester.

• Weight: 20% of course grade

• Length: 3 passages

- b) Write your exegetical essay. Further details of what is expected in your exegetical essay are included with the course materials. In addition, the processes and structure outlined in the Biblical Interpretation (111) course will be helpful.

B. CRITERIA FOR ASSESSMENT: GREEK OPTION

Critical translation

- Accurate Translation: That the translation is true to the Greek text USB 4th Edition.
- *Critical Notes*: That the translation is well supported with notes.
- *Contemporary Appropriateness*: That the translation reads well for English speakers in NZ today.
- *Textual Variants*: That note is made of the major textual variants and the reasons for the choices made (see especially Metzger, *A Textual Commentary*).
- *Structural analysis*: That the analysis recognises the syntactical markers and connectors that shape the direction and form of the unit as a whole
- *Dynamic equivalence*: That the translation reflects a greater awareness of 'thought for thought' equivalence, including (where appropriate) some equivalent colloquial phrases.

Exegetical essay

- Utilisation of appropriate tools and resources
- Clarity and depth of analysis
- Accuracy of translation from the Greek text, and appropriate application of language insights to the exegetical task
- Demonstration of exegetical competence in handling the text
- Coherence, development and presentation of argument
