ASSESSMENT TASKS AND DUE DATES

There are three assessment tasks

1. Participation in Online discussions

Learning Outcomes: 1, 3, 4

Due Dates; Midnight Sunday of semester weeks 1, 2, 3, 6, 8, 10, 12

Percentage Weighting: 25%

Length: Generally, 200 words per initial post, with at least 50 words

for follow-up posts.

Online discussion tasks require you to engage with various themes and circumstances. These tasks will require you to submit an initial post by the due dates shown above, followed by at least one response to at least one class member. The follow-up responses are due within one calendar week of your initial post.

Specific instructions in the learning guide will accompany each online discussion task. Students are required to participate in all seven online discussions.

2. Research Essay

Learning Outcomes: 1, 2, 3

Due Date: Midnight Sunday at the end of semester week 9

Percentage Weighting: 45%

Length: 2500 words

Write a 2500-word essay on **one** of the following topics. You may answer a question not on this list, provided you receive written agreement from your tutor on the wording of your question.

- a) Identify 3 key terms in Soteriology. Explain their biblical origins and theological nuances and discuss the development within contemporary theology of at least one of the terms (e.g., 'deliverer' in liberation theology).
- b) Is salvation static or dynamic? Relate your answer to the scope of salvation.
- c) Discuss the main teachings of Pelagius and their implications for salvation.
- d) Discuss what Christianity says about the human condition. Compare this with two major points of critical difference in contemporary western interpretations.
- e) "Sin is a corruption of the *individual* person, but it is also active and powerful in public and corporate structures of life" (Daniel Migliore). What does this mean in relation to the doctrine of sin? Include some contemporary expressions of this view.
- f) "If we did not know of salvation, there would be no sin" (Stanley Hauerwas). Comment and explain.
- g) Critically assess the interpretation of justification and deification in the new understanding of Luther.
- h) Discuss *theosis* as a model of salvation. Explore the extent to which it coheres with at least one later Protestant understanding.
- i) Compare and discuss the East and West on sanctification.
- j) Critically discuss election in the thought of Karl Barth.
- k) Connect Covenant and Cross in the drama of salvation. Include two theological models and critically evaluate their presentation of salvation.
- I) Analyze a work of visual art or music in terms of its soteriological content, identifying both relevant themes and methodologies. Theologically defend your evaluation of the work as a presentation of redemption.
- m) Compare and discuss Origen's teaching of *Apokatastasis* with von Balthasar on salvation.

This essay is a substantial piece of assessment. It is expected that you will provide evidence of the research you have undertaken in order to address the question/topic you have chosen. It is expected that **at least 3** major theological texts will have been consulted and reference to **at least 5** articles or other sources. Online websites will not be accepted as primary sources.

3. Movie Review

Learning Outcomes: 2, 4

Due Date: Midnight Sunday at the end of Study Week 1

Percentage Weighting: 30%

Length: 1200 words

Select a movie from the list below, and in your own words write a review. Concentrate on its eschatological references. These may be implicitly or explicitly Christian or an alternative to Christian models. Detail the way in which it expresses eschatological themes as related to salvation. You may limit the subject matter by picking out a theme or character and focusing on these as they symbolize or characterize eschatological notions (remember to identify if these are Christian, or otherwise).

Don't use internet resources, and don't use more than 200 words summarizing the movie.
