# 1. Critical book review

Weighting: 30% Length: 1500 words

Write a critical book review of the textbook: Goheen, Michael W. and Bartholomew, Craig G. Living at the Crossroads: An Introduction to Christian Worldview. Grand Rapids, MI: Baker Academic, 2008.

Your review should be approximately 1/3 summary, 1/3 discussion of concepts, and 1/3 application.

# 2. Research Report

Due date: Sunday end of semester week 7, 11.55 pm

Weighting: 25% Length: 1000 words

In preparation for your essay (Assessment number 3) write a report summarizing your research process. You should include details of your search strategy and your criteria for evaluating the chosen information and references.

# 3. Essay

Learning outcomes: 1. 2. 3. 4

Due date: Sunday end of semester week 10, 11.55 pm

Weighting: 45%

Length: 3500 words

Select a worldview theme from the list provided (or negotiated with your tutor). Examine the theme from the following perspectives:

- Your own worldview
- The worldview of a cultural group other than your own
- The worldview promoted within popular culture in New Zealand

Remember to use specific examples as you develop your critique. Critically evaluate all of these perspectives through a grid of biblical understanding and beliefs. Remember to use specific examples throughout your work.

- Time
- Place
- Truth
- Knowledge
- Success

#### **CRITERIA FOR ASSESSMENT:**

#### 1. Critical Book Review

- Accurate summary of the reading
- Critical engagement with the reading: Examination of the concepts; evidence that new thinking has taken place or new connections made.
- Valid application of the reading to life and ministry
- Clarity and structure of contributions: Logical and descriptive titles and structure; accurate spelling and grammar.

# 2. Research report

- Strategy for selection of information and references appropriate to level 7
- Critical evaluation of information and references
- Structure: Clear and logical arrangement of ideas; valid conclusions
- Communication & Presentation: Clarity, format, spelling, grammar; annotation and bibliography

#### 3. Essav

- Insightfulness: Distillation of worldview concepts from self, others and popular culture.
- Critical thought: incisive evaluation of aspects of worldview from different perspectives through the grid of biblical understanding
- Structure: Clear and logical arrangement of ideas; valid conclusions
- Communication & Presentation: Clarity, format, spelling, grammar; annotation and bibliography

# d. LEARNING HOURS:

270.615 is a 15 credit course consisting of 150 learning hours. The assignment tasks and learning hours are as follows.
