# Case Study / Analysis of a Personal Crisis

Learning Outcomes: 1, 2, 3, 5

Due Date: Midnight Sunday end of Semester Week 7

Percentage Weighting: 25% Word Count: 1500

#### **EITHER:**

1. Choose an <u>actual</u> pastoral situation that you are involved in or know about (disguise names, places, etc) and write a summary of the situation (i.e. what is happening, who is involved, what the needs are etc.). You may draw on a past situation if you wish.

- 2. Describe the <u>pastoral response</u> to that situation (what was actually done / what is being done).
- 3. Analyse and evaluate the pastoral response carefully (e.g. How did it meet the real needs of those involved? Was it designed to produce personal-spiritual growth? How was God brought into the situation? What else could be done?).
- 4. Identify in about 100 words ways in which your attitudes have been influenced by encountering this experience or by reflecting upon it. For instance, how has it affected your attitudes to ministry? To people with particular needs? To your own difficulties and challenges?

#### OR

ALTERNATIVELY, <u>analyze a personal crisis</u> (or a long-term difficulty) you have faced and the lessons contained in it for yourself and for pastoral care. You may like to utilise some of the questions / sections described above.

**Note:** Only a short bibliography is required, identifying 6 books or articles which have been helpful in addressing or understanding the crisis concerned.

Choose ONE of the following 3 topics and write an essay of 3000 words. Please note that the bibliographies listed here are indicative only, and you are not necessarily expected to read all the material listed in these bibliographies, but you will need to read and research beyond these lists in preparation for your essay. Your essay should show serious interaction with the reading you have done in preparation for writing this essay. You should expect to interact with at least 12 different resources.

Describe briefly some of the common characteristics of dysfunctional families.
 Discuss appropriate ministries to adults who have been raised in such families. (If you wish, you may narrow down the type of family background discussed. For example, you may wish to write about adult children of alcoholics, or children of divorce, or those with an abusive background. If so, indicate this in your essay title.)
