In your review, discuss the following:

- a) A brief summary of what the book is trying to say
- b) How well does the book succeed?
- c) What are the key issues raised?
- d) What is your personal response to these issues?
- e) How does this book add to the body of knowledge on Majority World theology?

In an **essay**, provide brief biographical details and describe the context (historical, social, cultural, economic, and political) within which the theologian lived and worked. Examine the ways in which the theologian's work relates to the specific context and identify and discuss at least three major themes addressed in that work. Comment on the theologian's contribution to theology in general and describe how the theologian's thinking has challenged your understanding of the gospel.
