Write a reflection on a psalm of lament, comparing and contrasting its themes to those of a movie and/or novel that feature similar themes. Use examples from each to illustrate your key reflections. Your reflection should also include a discussion of how the themes highlighted have been reflected in your own life.

Learning Outcomes 1 & 4

Write a critical response to the question raised by Tom Wright in *Surprised by Hope*: "The church is called to a mission of implementing Jesus' resurrection, and thereby anticipating the final new creation. What might that look like?" (p. 224).

Your essay should seek to answer Wright's question with particular reference to the context of suffering. In other words, what would it look like to anticipate the final new creation given the realities of a suffering world? Your essay should critically engage with Wright's theological perspective and also consider the connection between one's theology of suffering and one's understanding of hope. This will therefore require you to consider a range of theological approaches to suffering by both contemporary and classical theologians.

Learning Outcome 3

Tell your story to your reading group. Your story should highlight moments you experienced suffering and moments you experienced hope. Discuss the importance of human relationships in your story. Your story should draw analogies from film, television or literature.

Write a report of your group experience that includes the following:

- a summary of your story;
- a brief discussion of how you used analogies from film, television or literature;
- your reflections on the group's engagement with your story, and an evaluation of your own response;
- your reflections on your own engagement with other students' stories.
