1. COURSE STRUCTURE

The course runs through the first semester of 2015. The class dates are 13-16 April and 11-15 May 2015 at Laidlaw College, Henderson Campus. The course consists of pre-Reading, two teaching blocks of class time, and follow-up personal study to finalise a major research project. Interaction with a faculty adviser will also be important.

Communication between Course Coordinator and students, and the necessary forms and papers relating to the Course will be accessed through Moodle – The Laidlaw College Online Learning Management System.

First part: 1500 words

To be submitted by end of 12 April.

A. 2-300 words

Reflect on why you are doing postgraduate study. Try to be as specific as possible. Note down what you expect to have come out of your work when you have finished in terms of

1. results

- 2. you personally
- 3. what you will be able to do that you could not do before

B. 1200-1300 Words

Engage with the supplied articles by Coakley, Hitchen and Sutherland. Outline <u>your own</u> <u>understanding</u> of the theology of scholarship

Second Part: 500 words To be submitted on 15 May

A **Research proposal** of 500 words plus bibliography.

The shape of a research proposal will be discussed during the first block course. This proposal will relate to your research essay for this course.

Students will present a 10 minute oral synopsis of their research during the second teaching block.

Do not embark on your research until you have the agreement of your faculty adviser that your proposal is suitable. The faculty adviser will communicate their acceptance to the course coordinator, and to the student.

The Research Journal will be marked on these criteria

Assignment and reading have been completed Critical skill
Good application shown to student's own project
Clear structure and overall arguments
Good grammar and referencing

ASSIGNMENT TWO: RESEARCH PROJECT: 7000 WORD RESEARCH ESSAY [learning outcomes 5, 6] Due: Monday 29 June 2015 75%

Each student will submit a research essay on a literature-based topic negotiated with the course coordinator (developing the research proposal included in the Research Journal). This essay will embody the results of independent research and include a reflection on methodology. It will follow scholarly conventions and be written in a form which would be suitable for submission to a scholarly journal in the appropriate discipline.

The student will complete this essay with the advice of a Laidlaw faculty member in their field. The student will discuss their proposal and get the go-ahead of their adviser before starting their research and should expect to meet with the adviser twice more during the writing process.

NB: should the student wish to write a longer essay in order to obtain early entry to a PhD programme or as the basis for a scholarship application, this can be arranged by discussion with the course coordinator.

Research Project Grading Criteria

The stated topic has been fully addressed in terms introduced in the essay

Reading and research – sufficient, up to date sources are used as is appropriate for the content and method and question

Critical skill - sources and ideas are engaged critically, and available approaches assessed

Structure: Clear and logical arrangement of ideas; valid conclusions

Reflects on Methodology/Uses method with skill
