COURSE DESCRIPTION

Making choices and taking charge; enjoying the good life; wrestling with tragedy; addressing the sinful tendencies of human nature. This is the biblical quest for wisdom. It is found sharply focused in the texts of Proverbs, Job, Ecclesiastes and Song of Songs. This course explores the distinctive features of Old Testament wisdom and her texts, her key concerns, and her place in the life of faith, work and learning, ultimately to find that “the fear of the Lord is the beginning of wisdom and knowledge of the Holy One is understanding” (Prov. 9:10).

LEARNING OUTCOMES: At the end of the course students should be able to:

1. Demonstrate knowledge of the content of the main Old Testament wisdom texts.
2. Explain key concepts relating to the structure and formation of Old Testament wisdom texts.
3. Show critical awareness of the literary and cultural contexts of biblical wisdom literature.
4. Demonstrate an understanding of critical exegetical procedure, especially as it applies to the interpretation of Old Testament wisdom literature.
5. Reflect on contemporary life and ministry in the light of a reading of Old Testament wisdom texts.
6. [Hebrew option: demonstrate ability in reading and translating Biblical Hebrew wisdom texts.]
7. Articulate a cohesive biblical theology of wisdom.

CONTENT OVERVIEW:

- Historical, literary and environmental background to Hebrew wisdom literature.
- The book of Proverbs (NRSV).
- The book of Job (NRSV).

- The book of Ecclesiastes (NRSV).
- Song of Songs (NRSV) and the place of wisdom in the context of the biblical story.
- Wisdom and contemporary life and ministry.
- Theological response to wisdom.
- Wisdom and/in Scripture
- [Hebrew option: translation of Ecclesiastes 1-8]

ASSESSMENT TASKS AND DUE DATES (ENGLISH OPTION):

Contextual Reflection: 20%, due 10 March (posting 1); 31 March (posting 2); 5 May (posting 3); 26 May (posting 4)

Learning outcomes: 1, 5

Using the Forum function on Moodle, students will write four postings, due as indicated above, that link their reading of wisdom material currently being covered in class with events, public or private, that are going on in the world around them or being experienced directly by them. These postings should include insights from wider reading of news, current events and opinion pieces, and insights from wider reading about biblical wisdom. Students will also write a response to at least two of their classmates' entries. Forum entries are read by the whole class; while personal responses to events and experiences are welcome, no self-disclosure beyond a level that is appropriate and comfortable is required. Correspondingly, all entries should be treated with respect and held in confidence within the class group. It is anticipated that 1500 words will be written in total. Assessment criteria:

- Pre-reading passages read on time.
- Evidence of insights from wider reading on wisdom.
- Evidence of awareness of current events and opinions.
- Ability to discern the spiritual/theological significance of contemporary events.
- Depth of capacity to bring Scripture to bear on such events.

Exegetical Essay: 35%, due 28 April

Learning outcomes: 1, 2, 3, 4

A 2,500 word exegetical essay on the NRSV text of one of the following three passages:

- Proverbs 30.1-14.
- Ecclesiastes 11.
- Job 28.12-28.

As well as giving attention to key words and phrases, significant grammatical and syntactical constructions, and (where applicable) important textual or translational points, your exegesis of the passage should identify the setting, main literary features, and key aspects of the study of wisdom literature. Assessment criteria:

- Textual: are key issues of translation and textual variation identified?
- Literary: are the methods by which meaning is conveyed discerned.
- Context: is the passage understood in terms of its literary and historical context?
- Critical discernment: are the major exegetical issues selected and discussed?
- Significance: is the contribution of the passage towards a wider message perceived?

- Integration and reading: are the insights of scholars integrated into the treatment?
- Style and organisation: is the argument illumined by a clear structure and accurate and fluent use of English? Are appropriate footnote and bibliographic conventions used?

Thematic Essay: 45%, due 9 June

Learning outcomes: 1, 3, 5, 7

A 3,000 word thematic essay. The essay should incorporate in some way material from the contextual reflection journal as a pointer towards the relevance of biblical wisdom literature for today. The first topic is excluded for those who write their exegesis from Proverbs, the second for those who write from Ecclesiastes, and the third from those who write from Job. The essay should be on one of the following topics:

- Examine the key themes that underline the idea of wisdom conveyed by the Book of Proverbs.
- Is it possible to develop a synthesis of the message of the book of Ecclesiastes? If so, what might that be?
- In what sense might the conception of the book of Job as a narrative help the reader to appreciate its message?
- “Wisdom theology is creation theology” (Zimmerli). Discuss this statement.

Assessment criteria:

- Coverage of relevant content.
- Development of argument.
- Integration of ideas.
- Critical reflection.
- Extent and quality of reading and research.
- Incorporation of material from contemporary context
- Style and presentation, accurate use of English.
- Effective footnoting and observance of bibliographic conventions.

ASSESSMENT TASKS AND DUE DATES (HEBREW OPTION):

Hebrew Translation: 25%, due 9 June

Learning outcome: 6

Students will attend a weekly 60 minute translation tutorial during which all or most of Ecclesiastes 1-8 will be read through. Students should be prepared to read and translate the set texts for the day in class. Students will also write a critical translation of three passages from Ecclesiastes 1-8 of approximately 20 lines each in the BHS text. The translations should represent the semantic and lexical characteristics of the passage in question as far as possible within the bounds of acceptable English usage. Where there is a tension between these two requirements, this should be reflected in a footnote. The translations should also include footnotes, explaining the choices where it is needed and where there are textual variants or issues. Failure to attend 80% of the tutorials and/or to attend but be unprepared will result in a 20% mark penalty.

Assessment criteria:

- Accuracy of lexical selection.
- Accuracy of semantic reflection.
- Discretion shown in translation choices.

- Awareness of textual issues.

Exegetical Essay: 35%, due 7 April

Learning outcomes: 1, 2, 3, 4

A 2,500 word exegetical essay on the Masoretic Text of one of the passages chosen from Ecclesiastes 1-8 for critical translation. The essay should assume that translation. As well as giving attention to key words and phrases, significant grammatical and syntactical constructions, and (where applicable) important textual or translational points, your exegesis of the passage should identify the setting, main literary features, and key aspects of the study of wisdom literature. Assessment criteria:

- Textual: are key issues of translation and textual variation identified?
- Literary: are the methods by which meaning is conveyed discerned.
- Context: is the passage understood in terms of its literary and historical context?
- Critical discernment: are the major exegetical issues selected and discussed?
- Significance: is the contribution of the passage towards a wider message perceived?
- Integration and reading: are the insights of scholars integrated into the treatment?
- Style and organisation: is the argument illumined by a clear structure and accurate and fluent use of English? Are appropriate footnote and bibliographic conventions used?

Thematic Essay: 40%, due 9 June

Learning outcomes: 1, 3, 5, 7

A 3,000 word thematic essay. The essay should include a pointer towards the relevance of biblical wisdom literature for today. The essay should be on one of the following topics:

- Examine the key themes that underline the idea of wisdom conveyed by the Book of Proverbs.
- In what sense might the conception of the book of Job as a narrative help the reader to appreciate its message?
- “Wisdom theology is creation theology” (Zimmerli). Discuss this statement.
