### **CONTENT OVERVIEW**

This course is designed for the trainee teacher to draw on repertoires of knowledge, practices, professional attributes and personal philosophy of teaching to facilitate learning for the classroom in a full responsibility capacity over a five-week period following a one week orientation and preparation period.

- a. Six weeks supervised practice
- b. Orientation, planning, and preparation
- c. Sustaining full responsibility of a learning environment
  - administration
  - effective teaching
  - safe learning environment
- d. Reflection and journaling
- e. Professional and personal integrity and ethic
- f. Integrating theory, practice and personal philosophy of teaching

### **ASSESSMENT TASKS AND DUE DATES**

#### **ASSIGNMENT ONE**

Students will undertake a 6 week practicum to demonstrate competency in meeting the *Education Council of Aotearoa NZ Graduating Teacher Standards*. A summative assessment of competency will be documented by the associate teacher in the Associate Teacher's Assessment Report. The AT's overall teacher judgment will be guided by formative assessment collected through regular written and verbal feedback to the teacher trainee, professional conversation, evidence of teacher trainee learning and progress, as well as consultation with the visiting lecturer.

## **ASSIGNMENT TWO**

Students will teach across a block of time to demonstrate competency to plan and deliver purposeful learning for all children. A visiting lecturer will view the teacher trainee's performance, debrief with the trainee, and provide a summative assessment as outlined in the Visiting Lecturer Report.

- Effective implementation of appropriate management strategies
- Responsiveness to diverse learners and contextual complexities

## **ASSIGNMENT THREE**

- school and classroom administration
- personal professional goal setting
- professional reflection with direct links to personal goals and teaching philosophy
- all planning, teaching, assessment and evaluation to required standard
- specific artefacts as evidence of meeting the *Graduating Teacher Standards* (Education Council NZ)

Students will provide proof of:

- a planned and organised collection of artefacts and reflections meeting the professional standards and practices as outlined in the assessment rubric.
